

CONSENT TO PROCESSING OF PERSONAL INFORMATION AND NOTICE IN TERMS OF THE PROTECTION OF PERSONAL INFORMATION ACT 4 OF 2013 (POPIA)

Words and phrases defined in the Rules of Auction and Terms and Conditions of Sale (Conditions) available at www.foresyteauction.com have the same meaning in this consent and notice unless otherwise expressly stated or clearly apparent from the context.

1. I wish to register as a bidder for the Auction.
2. I understand, accept and agree to Foresyte Stud CC of 25 Pauline Crescent, Summerveld, Kwazulu Natal, South Africa (**Foresyte**) collecting and processing the following personal information (**Personal Info**) including my name, identity and/or passport number, citizenship, address, financial information relevant to invoicing and payment of the purchase price for any lot, information about any person whom I represent including their names, identity, passport or registration numbers and where they are legal persons or trusts, information identifying their ultimate beneficial owners.
3. Where I provide the Personal Info of any third party to Foresyte, I warrant that I have the express written consent of the data subject to do so and that I do so in compliance with POPIA. **I indemnify Foresyte against any claims arising from or relating to its processing of the third party's Personal Info, including claims made by the third party, and which arise because my sharing of the third party's Personal Info with Foresyte did not comply with POPIA.**
4. I understand, accept and agree that Foresyte may process the Personal Info in relation to the Auction and including for the following purposes:
 - 4.1. managing and running the Auction;
 - 4.2. concluding contracts of sale for the horses at the Auction and performing those contracts;
 - 4.3. issuing invoices and receiving payment of purchase prices and other amounts owed in relation to horses sold at the Auction;
 - 4.4. compliance with applicable laws including those regulating auctions (Consumer Protection Act), tax (Income Tax Act and Value Added Tax Act) and money laundering laws (the Financial Intelligence Centre Act, 2001);
 - 4.5. managing any possible claims;
 - 4.6. taking out and managing insurance in relation to the Auction;
 - 4.7. the inspection and trying out of horses on Auction;
 - 4.8. communication with bidders and buyers in relation to the Auction and any sale.
5. I give consent to Foresyte Auction to use my personal information and data for marketing purposes and social media relating to the Auction. I understand that I can withdraw this consent for marketing purposes at any time by emailing Foresyte at info@foresyteauction.com

6. I understand that to the extent that Foresyte is required to collect and process the Personal Info by law, I will not be permitted to participate in the Auction as bidder or buyer unless I provide the Personal Info to Foresyte.
7. This constitutes my consent, to the extent required under Section 11(1)(a) of the Protection of Personal Information Act 4 of 2013 ("**POPIA**") to the processing by Foresyte of the Personal Info as described in this Notice.
8. **PRIVACY POLICY & POPIA**
- 8.1. In compliance with the provisions of POPIA, Foresyte confirms that during the collection, use and other processing of my Personal Info and that of any other data subject whose Personal Info I provide to Foresyte, Foresyte applies the principles of POPIA by, amongst other things:
 - 8.2. limiting access, use and storage of the Personal Info to Foresyte, its members, employees and/or third parties (including the Insurer and Auction House) who are required to have access thereto for the purposes described earlier in this Notice;
 - 8.3. taking reasonable steps to secure the Personal Info including anti-virus software and other appropriate and reasonable security precautions in relation to the information technology (IT) system used for the Auction;
 - 8.4. only keeping the Personal Info for the longer of the period required for the Auction or prescribed by law or as required to deal with any claims or queries relating to the Auction;
 - 8.5. allowing you to access all your Personal Info which Foresyte may have at any time to the extent required by POPIA and on reasonable request in accordance with POPIA;
 - 8.6. rectifying any Personal Info which you notify us is incorrect;
 - 8.7. notifying you of any unauthorised access to your data or which Foresyte becomes aware;
